Guidelines for UAS

The Industry Wide Labor-Management Safety Committee has released new information regarding Unmanned Aircraft Systems (drones).

Safety Bulletin #36—Recommended Guidelines for Safely Working Around Unmanned Aircraft Systems (UAS) is a new bulletin that reflects changes in UAS technology and federal regulations regarding their use. Previously, this bulletin discussed miniature remote-controlled camera helicopters and was named accordingly.

Addendum A—Unmanned Aircraft Systems (UAS) Exemption Summary details the new exemption granted by the FAA to the motion picture and television industry for outdoor use of UAS under specific conditions.

Guidelines for Working in Extreme Cold Temperature Conditions

Safety Bulletin #34, which gives guidelines for working outdoors in extreme cold weather, has recently been revised. Safety tips include dressing properly, providing your body with the appropriate nutrients and fluids, adequately securing equipment, and having emergency supplies readily available.
